The leaders who gathered more than twenty years ago discussed trends and different approaches to successfully handling potential risks and attacks on law enforcement, and they found the benefit of establishing a network of communications with other leaders. From that year on, a leadership seminar was held yearly in Cambridge and remained by invitation only, becoming a cherished tradition. Throughout the years, professors and professionals in law enforcement-related fields continued to share their knowledge and research on topics, trends, and forecasts, adding to the rich history of the seminar.

John Rivera, who served as president of the Florida and Dade County Police Benevolent Associations, was one of only three law enforcement leaders who spoke to academics at Harvard more than twenty years ago. His dynamic presentations and insight on law enforcement matters had him invited back every year as an attendee, speaker, or panel member.

In 2019, Cynthia Brown and Dr. Elaine Bernard retired. Instead of letting this important seminar cease to exist, John Rivera took the helm with Cynthia Brown's encouragement and support. He then partnered with longtime colleagues Blanca Torrents Greenwood, Esq., and Stephanie M. Womble.

The BIG50 seminar remains an invitation-only event where we seek out the best, brightest, and most influential leaders in the law enforcement community to attend this prestigious seminar. Our team is committed to continuing and building upon the work of Cynthia Brown and Dr. Elaine Bernard in Cambridge - creating a professional forum where law enforcement leaders can unite to find innovative ways to serve the membership and advance the law enforcement profession.



JOHN RIVERA | Partner

John Rivera, a retired Miami-Dade Police Department Sergeant and former President of the Florida Police Benevolent Association and Dade County Police Benevolent Association, is a founder and President of The BIG50.

During his law enforcement career, Rivera took countless violent criminals off the streets. Rivera worked in the Organized Crime Bureau, investigating cases involving organized crime, as well as political and public corruption. He was also the lead investigator on the Mariel Task Force.

Throughout his career, Rivera faced situations that became the foundation for his unwavering advocacy of law enforcement officers and the challenges they faced: Rivera was shot in the line of duty while thwarting an attempted armed kidnapping and held a fellow officer as he died in Rivera's arms. That is why John Rivera is so adamant about never forgetting those who serve and protect.

Rivera's calling to be a voice for law enforcement began in 1989 when he was elected to the Dade County PBA Board of Directors. He served on the board until December 1992, when he was elected president of the Association. He served as the longest Dade County PBA President from January 1993 through 2018. Rivera also served as president of the Florida PBA, which represents 30,000 officers across Florida. He is a vocal advocate for law enforcement and is committed to educating the public on the challenges officers face daily.

Rivera was appointed by the Governor to serve as a Commissioner on the Florida Department of Law Enforcement's Criminal Justice Standards and Training Commission, overseeing the training and certification of all sworn law enforcement personnel in the state of Florida. He's also served as a member of the Task Force on Performance and Efficiency in Miami-Dade County Government.

Rivera has lectured across the country at various symposiums, including Harvard University, on topics facing law enforcement and the role of labor unions. In 2011, Rivera was asked to share his leadership and insight at the National Executive Session on Policing and Public Safety sponsored by the Harvard Kennedy School, the National Institute of Justice, and the White House Office of National Drug Control Policy.

Rivera also hosted the Rapid Response Radio Show on 880 The Biz; repeatedly appears on national and local television programs commenting on law enforcement issues and solutions to problems facing our law enforcement community; and has been published in numerous publications.

He is the recipient of many awards, including the Sherman Winn Award for his commitment to the community, and the Concerns of Police Survivors "Distinguished Service Award."



BLANCA TORRENTS GREENWOOD, ESQ. | Partner

Blanca Torrents Greenwood, Esq. has been practicing law since 1991. As a Dean's List graduate from the University of Miami, Ms. Greenwood received her Bachelor's Degree in psychology, with a minor in chemistry, in 1988. She attended the University of Miami School of Law as a recipient of the Dean's Honor Scholarship and received her Juris Doctorate in May 1991. She was selected for the Law School Honors Program and served as President of the Hispanic Law Students Association and Executive Board Member of the Phi Alpha Delta Law Organization. Ms. Greenwood was the University of Miami School of Law Mock Trial Competition Champion and represented the University, placing as a Finalist, in national trial competitions. Ms. Greenwood started her legal career as an Assistant State Attorney for the Eleventh Judicial Circuit, Miami-Dade County, where she prosecuted all level of crimes. She was appointed as Deputy Chief of the County Court Division where she oversaw the training and development of newly hired prosecutors, in addition to handling sensitive cases within the division. During her tenure as an Assistant State Attorney, Ms. Greenwood also ran the Drug Court Division and successfully prosecuted hundreds of cases.

She later served as General Counsel and Executive Director of the Dade County Police Benevolent Association, a labor organization representing law enforcement officers and civilian support personnel in all matters related to their employment, including collective bargaining and arbitrations. Ms. Greenwood served as advisor to the President and Board of Directors, providing legal opinions on policies, changes in the law, and proper direction, as well as all official messaging and position statements. Ms. Greenwood served as co-host and content developer for the Rapid Response Radio show, a weekly radio program addressing topics and issues affecting the South Florida community and law enforcement. Ms. Greenwood also served as Associate General Counsel for the Florida Police Benevolent Association, where she was intricately involved with legislation and pension issues throughout the state. She currently works with the law offices of Klausner, Kaufman, Jensen & Levinson, which is devoted to representing public pension boards throughout the country and handling labor and employment matters.

Ms. Greenwood is licensed to practice law in the State of Florida and the United States District Court for the Southern Region of the United States. She is married to retired Miami-Dade Police Sergeant Kevin Greenwood, and they have three children.





Kevin Selent, Rogue Targets



Kevin Selent | Rogue Targets

Kevin Selent has been in law enforcement for more than 20 years. Fourteen of those years as a member, K9 handler & Team Leader of a Federal Tactical Team. He was also a Tactics Instructor and has trained with the best units in the world. He created these targets because he grew frustrated with trying to teach deliberate clearance (CQB/CQC) using shooting targets that weren't conducive to the actual training environment. The current targets on the market all have backgrounds that are not realistic and not practical for CQB/CQC training. For example, when training in deliberate clearance, the end users shouldn't encounter an angry subject in a construction zone holding a shotgun or a pixilated picture of a woman holding a knife in a public library. This isn't real.

ROGUE TARGETS are high-quality pictures of subjects who may or may not be a threat. These pictures are what end users will see when conducting tactical entries into buildings or structures. The current targets on the market are outdated, pixelated, cartoonish, and just plain

ridiculous. ROGUE TARGETS help the end user identify a "Shoot" or "No Shoot" subject by providing the most vivid and high-definition images on the market. These targets help the end user scan the entire room before entering by using different elevations, from standing to sitting, corner targets, and even ground targets. Rogue Targets also come with self-adhesive so training instructors don't have to worry about using tape, nails, or spray glue to affix them to the training structure.

Impact of HR 82, Social Security Fairness Act of 2023 Brian Marvel, PORAC President



Brian Marvel | President of PORAC

Brian R. Marvel is a Police Officer III with the San Diego Police Department (SDPD) and has served for over 25 years in policing. His career includes a decade in patrol operations, specialized roles in demonstration control (Bravo Team), Psychiatric Emergency Response Team (PERT), and a Terrorism Liaison Officer (TLO). His last assignment was in the Research, Analysis, and Planning Unit and as the Military Liaison officer for the department. He is a veteran and an adjunct professor at the San Diego Regional Police Academy.

Mr. Marvel's first elected PORAC position, in 2015, was President of the San Diego-Imperial Counties chapter of PORAC, covering federal, state, and local associations from the Pacific Ocean to Arizona along the California-Mexico border. In 2017, Mr. Marvel was overwhelmingly elected President of PORAC, an 86,000-member-plus organization, and is currently serving in his fourth two-year term. Mr. Marvel is the vice-chair of the California Governor's Public Safety Officer Medal of Valor Review Board and board member on the California Peace Officers Memorial Foundation. Mr. Marvel is the fourth PORAC President from the SDPOA.

Prior to his election as PORAC President, Mr. Marvel served 10 years as president of the San Diego Police Officers Association (SDPOA). He was the longest-serving president in the 113-year history of the SDPOA. As Past President of Californians Against Slavery, he championed Prop 35 (2012), a landmark initiative combating human trafficking, the most successful ballot initiative since California began the process in 1914.

Mr. Marvel is a contributing author to *Police Unions and the Reform Movement: The Battle for the Future of America's Police* and *Law Enforcement, Police Unions, and the Future: Educating Police Management and Unions About the Challenges Ahead.*

For 10 straight years, Mr. Dell has been selected as a Super Lawyer by Thomson Reuters. A member of the New York Bar and the Florida Bar, Mr. Dell is a frequent lecturer at New York Injured Worker Bar Association events, and is also a member of Florida Workers' Advocates, groups which protect the rights of injured workers throughout New York and Florida.

Mr. Dell earned his BA degree from the State University of New York at Binghamton in 1991, and his JD from the City University of New York at Queens College School of Law in 1994.

For twenty-five years, Mr. Dell worked as a NCAA Division I Hockey Referee. Mr. Dell also served as a National Hockey League (NHL) Trainee and officiated his 1st NHL game on January 23, 1992 between the Toronto Maple Leafs and the New York Islanders at Nassau Coliseum in New York. Association



Jeremy Schmidt | President, Santa Clara Police Officers' Association

Sergeant Jeremy Schmidt is a seasoned law enforcement professional with over 16 years of dedicated service to the community. A proven leader, Sergeant Schmidt has served multiple terms as president of two police associations. During his tenure, he successfully negotiated back-to-back, market-leading labor contracts and secured the Police Department's share of a \$400 million infrastructure bond—raising the initial allocation from \$0 to \$40 million.

His work extends into the political arena, where he made history by winning a landmark election to overturn an initiative to eliminate California's only elected Chief of Police—an upset that saw him earn 72% of the vote.

Additionally, under his leadership, the POA won the Mayor's race against overwhelming financial odds, prevailing despite being outspent \$2.5 million to \$80,000 by opponents backed by the San Francisco 49ers. This outcome secured a stunning victory that underscored the POA's deep community support, as well as his ability to lead high-stakes initiatives, mobilize grassroots engagement, and deliver results against powerful opposition.

Within the department, Sergeant Schmidt has developed a strong commitment to defending his fellow officers. He has successfully achieved favorable outcomes in numerous disciplinary actions. He has also played a pivotal role in forming a coalition to reject NFL credentialing mandates, protecting department autonomy and officer rights.

Currently assigned as a patrol supervisor, Sergeant Schmidt continues to serve on the front lines. He brings over 12 years of tactical experience, including specialized roles as an explosive breacher and as the lead of the department's explosive breaching cadre, highlighting his operational skill and tactical leadership.
